

Reviewing Literature Research on Integrity Issues

Abstract: These days, the record number of criminal demonstrations of defilement in Indonesia is still at a high level. Integrity turns into a significant value that is expected to forestall the event of degenerate conduct. The developing number of integrity and debasement research intrigued numerous researchers with regard to high education institutions in Indonesia. The point of this study is to portray mapping ideas subject of interest from the certain purpose of perspectives. Information was gathered from 93 research article which is published and documented on Portal Garuda Indonesia. From this exploration, we can infer that the majority of research on integrity was oriented on the social environment rather than individual object points of view and still is very limited on social and local wisdom culture perspective.

1 INTRODUCTION

The idea of integrity deals with association of words with activity. It can likewise be translated that honesty is a frame of mind that is inborn inside an individual to have the option to assume liability for his self-activities. This sort of mentality must turn into a day by day propensity that shows up in somebody's conduct.

This integrity turns into a significant worth, which should be imparted in each person since at an early age. Respectability is expected to forestall demonstrations of debasement, where these activities can be perceived in light of the fact, that they are self-arranged, and further detrimentally affect others

Nowadays, the record number of criminal acts of corruption in Indonesia is still at a high level. Data from the Central Statistics Agency (BPS) in 2017 shows that the Indonesian Corruption Behaviour Index (IPAK) data is at 3.71 (Source: kompas.com, 2017). On a scale of 0-5, it means that Indonesia still has a lot of corrupt behavior.

Meanwhile, between January and 30 June 2017, Indonesia Corruption Watch (ICW) recorded that 226 cases of corruption, with a total of 587 suspects. The action cost the state around Rp 1.83 trillion and Rp 118.1 billion in bribes. (Source: detik.com, 2017)

The efforts to prevent corruption continuing cases not only carried out by the Corruption Eradication Commission (KPK) but also by higher education institutions and other social community-based. These

efforts can be made in 4 (four) approaches that are often applied in developing countries.

The approach was explained by Wijayanto (2009; 43-48), namely the lawyer approach (lawyer approach), the entrepreneur approach (business approach), the market or economic approach (market or economist approach), and the cultural approach (cultural approach). The lawyer approach, the entrepreneur approach, and the economic approach are often implemented in the public and private sectors. Meanwhile, the fourth approach, culture (Cultural approach), emphasizes the micro sector, where each individual is raising awareness of the integrity attitude in daily life.

This examination endeavors to follows the thoughts from past inquire about which has been finished by researchers. Literature was reviewed in order to find mapping topic and domain research.

2 CONCEPTUALIZATION OF INTEGRITY

David H. Barley (in (Robert, 2005) explains the notion of the concept of corruption is relating to acts of bribery includes the abuse of authority for personal

benefits, which are always monetary in nature. Corruption is also defined within Pasal 2 ayat (1) UU No. 20 in 2001, revised from UU No. 31 in 1999 concerning about Eradication of Corruption, as, "Setiap orang baik pejabat pemerintah maupun swasta yang secara melawan hukum melakukan perbuatan memperkaya diri sendiri atau korporasi yang dapat merugikan keuangan negara atau perekonomian negara." (Everyone, both government and private officials who unlawfully commit acts of enriching themselves or corporations that can harm the country's finances or the country's economy).

According to Montefiore and Vines (1999: 22), "Integrity is the capacity to stick to one's fundamental commitments or principles in the face of other pressures." Integrity is the basic ability of a person to commit or strengthen himself when faced with pressure conditions that coincide to make a decision immediately.

An important aspect of character integrity is "Honesty and sensibility—a capacity to see truly and a capacity to feel deeply—are ideally brought together in a morally mature response to the world." (Montefiore & Vines, 2005) The most important part of the value of integrity is honesty and high sensibility.

The Ministry of Education and Culture then tries to compile an Anti-Corruption Education lecture module for tertiary institutions (Kemendikbud, 2013). Within these modules, 9 (nine) concepts of integrity are compiled, namely, honesty, caring, independence, discipline, responsibility, hard work, simplicity, courage, and justice.

The dimensions of integrity values that form the terms of reference in this study refer to honesty and sensibility. The value of honesty is identified from behavior that reflects transparency, independence, discipline, responsibility, and hard work, while the value of sensibility is identified from behavior that reflects caring, simplicity, courage, and fairness.

3 LITERATURE REVIEWS DISCUSSION

Data is collected from Garuda Portal (<http://garuda.ristekdikti.go.id>). This portal contains lots of research documents which have been done by various higher education institution in Indonesia area.

3.1 Research Domain

The Concept of "integrity" was used to find out any researches which have been published in 5 (five)

years ago, between 2014-2019. We have 106 research from various major which can be accessed to gain full article paper. For the following second step, we separated again to choose for just social research, and after that, we have just 93 test articles.

From the list, we acknowledged that academic publication with "integrity" word within their titles not rooting from any major science. The implication of integrity can be found from various points of view. The discussion not only limited in law or social science but also used in nature or physical science such as construction, biology, nursing, medical term, and others.

3.2 Discussion of Literature Review

The concept of integrity is often associated with honesty. Individuals will accept individuals who have good high integrity as great individuals (Macfarlane, Zhang, & Pun, 2014). The individuals who have integrity have sufficiently high mindfulness to separate themselves. In social situations where many people have a conflict of interest, people who have high honesty will not find it difficult to refrain from impulses to commit fraud. He will easily consider any situation that he has to make a decision between main rights and obligations when in the public sphere.

An understanding of the concept of integrity is in line with understanding from the law. Integrity can be comprehended as having a frame of mind regarding or regarding the presence of others (Fielden & Joyce, 2008) is an intelligent outlook to perceive what is the property of one's own and which is the property of others or shared property. The suggestion will be progressively entangled while the property put in open space.

This study seeks to find important concepts of public concern when researching by carrying out anti-corruption issues. The word integrity is often used as an antidote to corruption. In spite of the fact that the issue of integrity can form into a few equivalent words. In this paper, we need to attempt to explore by just utilizing one idea of "integrity."

3.2.1 Science Category

We listed the research articles one by one. Then we examined it by using several concepts to create subcategories. The results are quite interesting and should be proposed to develop as the subject of concern for academics.

Research publications on the subject of integrity do not start from a solitary control of strength. The concept of integrity can be investigated through

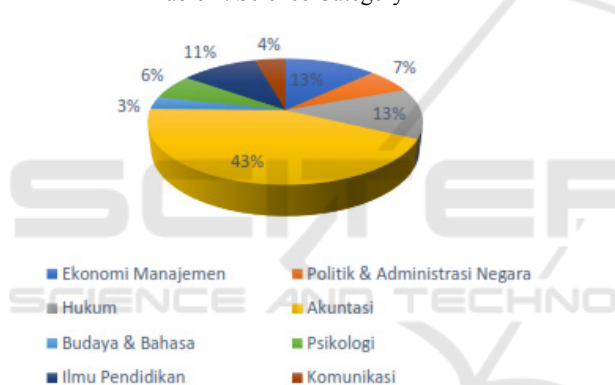
different logical points of view. Hence investigate the issue of integrity is discussed in different fields of science.

The same conditions are also found in economic studies and management, which are in the same field as an accountant. Integrity is also playing a very important role when discussing economic problems and human resource quality of management.

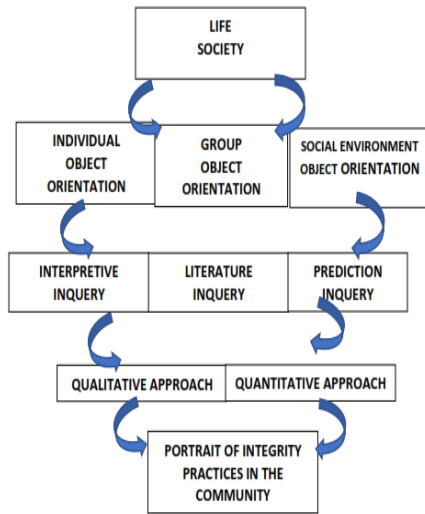

For example, integrity issue is likely not an important subject in the fields not only of communication, psychology, education but also in socio-cultural change while the socio-cultural of integrity is a significant aspect in the construction process of social life in society.

You do not need to give such kind of extra fees.

The education aspect is also not considered as important even though the anti-corruption attitude needs to be instilled at an early age. Likewise, in the field of communication, academics do not look at the issue of integrity as a major issue. Though communication plays an important role when socialization is carried out.

3.2.2 Topic of Interest

Furthermore, we also examine that integrity issue is divided into at least 3 (three) important orientation parts, namely the study of the internal aspects of individuals, teams or groups and the general community social environment.

The results of our study see that 39% of research is oriented to the individuals or the internal aspects of integrity. The attention of this orientation emphasizes self that determines one's integrity capital. Man is the center of his actions. From this point, people considered as who needs to be encouraged to play a greater role in upholding the issue of integrity. It is a main problem to solve and have a free will to determine the course of action.

What's also interesting is knowing that there are about 60% of research-oriented to the social environment in which individuals are located. In this case, the environment is a factor that plays a more important role in upholding one's integrity capital. Humans are considered easily influenced by their environment. The researchers looked at aspects of the work environment where individuals or groups are in a team or community is important to be studied.

Unfortunately, the results of our study documented research more oriented to the work environment. Social, environmental factors are seen more determines the integrity of a person. The amount of research that addresses humans in the school and family environment is very limited — likewise, broader aspects of the social environment, which is oriented to the law.

3.2.3 Choice of Research Methods

The research methods used to examine the issue of integrity are also not diverse. Most studies use an empirical approach that emphasizes questionnaire data collection techniques and data processing using statistical procedures.

Such conditions certainly need attention: behavior or moral integrity of humans as something that can be calculated. Humans are like robots, where their actions can be predicted. Such conditions are different from the understanding that humans are social creatures that are difficult to predict.

Nevertheless, there are about two studies that use the quasi-experimental method. The researcher tries a treatment action and then observes or measures the changes that happened after then. Research like this is interesting to develop when breakthroughs on integrity campaign messages are played to the public. Such an evaluation is needed to measure its effectiveness rather than just testing rigid hypotheses.

The inquiries about the integrity issues in people society, managing a subjective methodology, is discovered very little documented. Only about 10% of 93 articles use qualitative approach research by using interviews and observations for collecting data.

We expect that the understanding or idea importance of honesty is a fascinating viewpoint that ought to be studied further. The significance of integrity is, at some point, regularly out of reach when just depending on quantitative research. Numbers can just only depict. However, it could not explain more or clarify.

The results of the study also found that there were 24% of article documentation using literature studies. It seems to discuss and use the concept of integrity is more important than trying to examine integrity with the approach of other alternatives such as a qualitative approach

4 CONCLUSIONS

At the end of this description, our researchers can conclude that integrity is a significant aspect in society, but the understanding of the academics on the issue needs to be continuously sharpened.

Research that emphasizes the word or concept of integrity in the last 5 (five) years of documentation is not diverse. The issue of integrity is discussed in a simple and limited context. However, the problem of corruption in society is far more complex.

The mapping of research results, as illustrated in the study of this literature, becomes an opportunity as

well as a challenge for all academics from all disciplines to work together and expand the scope of the discussion. This step is needed to help reduce the number of corruption cases in Indonesia. Research on the issue of integrity in educational institutions and the government still seems to be wide open for analysis and also local wisdom cultural issues.
